#### **SELECTION OF BORROWER**

Following receipt of applications from “Borrowers” the Morris Register will:

- (i) Acknowledge receipt of each application and indicate the date by which selection will be made.
- (ii) Assess and short list applicants (Preferred, second & possibly third). Send a copy of the loan agreement to each short listed candidate seeking comment (provides opportunity for candidate to withdraw prior to final selection).
- (iii) Interview shortlisted applicants by telephone and subsequently the preferred candidate in person. Advise shortlisted candidates to keep the loan car hand over date clear.
- (vi) Make selection and advise “winner” of his/her successful application at least 10 days prior to hand over date. If “Winner” accepts, then non-winners will be advised that they have been unsuccessful.

#### **DATA PROTECTION**

The Morris Register will store your personal details for the period of the loan car application and the subsequent assessment period. Except for the selected individual, all other applicants’ personal details will be destroyed by 31st March 2018.

During the latter stages of our selection process, we may wish to provide your details to our insurer (Lancaster Insurance Services), but we will contact you before doing so.

The Morris Register will retain personal details of the winning applicant for the period of their membership of the Morris Register.
